CONDITIONS OF CERTIFICATION

- 1. Bulkhead shall be constructed of aluminium insulated on the stiffened side on the plating and around stiffeners & the unstiffened side with one layer of 'ISOVER U SeaProtect Slab 66" mineral wool produced by SAINT-GOBAIN ISOVER G+H AG (Nominal Thickness 70mm, Nominal Density 66kg/m³). Inside the cavity of the stiffeners two layers of "ISOVER U SeaProtect 66" mineral wool shall be applied, total thickness (70mm+20mm). The insulation was fixed to the plating 3mm aluminium-tipped steel pins & 38mm steel washers with horizontal & vertical centres not exceeding 300mm & 150mm from insulation joints. Arrangement of steel pins on the plates shall be in accordance with the referenced fire test reports and supplement to fire test report.
- 2. The insulation system was tested on a 4mm aluminium core and met all insulation and integrity criteria for a load bearing aluminium bulkhead of required fire rating; therefore, it could be considered for use as an aluminium bulkhead of a thickness of 4mm or greater.
- 3. Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance System (Module D), a Product-Quality Assurance System (Module E) or a Product Verification Process (Module F), as applicable. The UK Conformity Mark cannot be affixed to the product until a conformity assessment module is in place.
- 4. Each item, batch or lot of the subject equipment is to be issued with a "UK Declaration of Conformity" and have the "UK Conformity Mark" affixed after a conformity assessment module is in place.
- 5. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products are fully compliant with the relevant statutory regulations as applicable and are designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
- 6. Should a change of Place of Production from that stated below be required i.e., where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained.
- 7. The manufacturer must keep a copy of the UK type-examination certificate, its annexes, and additions together with the technical documentation at the disposal of the national authorities for a period of at least 10 years after the UK Conformity Mark has been affixed on the last product manufactured and, in no case for a period shorter than the expected life of the marine equipment concerned.
