CONDITIONS OF CERTIFICATION

1. Limited to application on metallic substrates.
2. Tape assembly shall consist of: (from exposed face) with a total maximum thickness of 150µm.
 - Glass Fibre Fabric at a maximum ratio of 110g/m²
 - Water-resistant, solvent free acrylate adhesive at a maximum ratio of 90g/m²
3. Smoke and toxicity criteria are satisfied by meeting the total heat release (Qt) and peak heat release rate (Qp) as stated in IMO Fire Test Procedures Code, Annex 2, Section 2.2.
4. Composition of individual components, including any adhesives and flame retardants, to be maintained in production in accordance with originally tested composition formula.
5. Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance System (Module D), a Product-Quality Assurance System (Module E) or a Product Verification Process (Module F), as applicable. The UK Conformity Mark cannot be affixed to the product until a conformity assessment module is in place.
6. Each item, batch or lot of the subject equipment is to be issued with a "UK Declaration of Conformity" and have the "UK Conformity Mark" affixed after a conformity assessment module is in place.
7. The certificate holder is solely responsible for the products supplied under this Certificate and to ensure that their products are fully compliant with the relevant statutory regulations as applicable and are designed, manufactured and installed to the same quality and specifications as the prototype tested, including components that are designed and manufactured by third parties.
8. Should a change of Place of Production from that stated below be required i.e., where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained.
